- Oversee the pipeline for producing new programmes managing internal and external resources
- Oversee the registration, production of new qualifications such as diplomas working collaboratively to develop content and materials.
- Oversee the administration team for all training and qualifications
- Maintain all relevant accreditations such as with skills bodies and assessment bodies.
- Ensure positive relationship and meet all requirements of relevant accrediting and assessment bodies
- Ensure effective quality assurance of programmes and qualifications including Kirkpatrick model of evaluation
- Oversee the continuous improvement process of all training and qualifications
- Ensure effective feedback to the development team comms and marketing team on impact of training and qualifications.
- Ensure a culture and ethos of continuous improvement and excellence within the team



- Ensure clear and effective systems and processes in place from application to quality assurance to ensure Bild Group is an example of best practice in training and qualifications.
- Have a current understanding of workforce development and qualification pathways in health social care and education
